

**CORRIGENDUM**

Pursuant to the pre-bid meeting held on 11-01-2024, the advertisement inviting R.F.P to establish Dialysis Units on PPP Model at ESI Hospitals, Bhubaneswar and Choudwar published vide this Directorate R.F.P No.02/DESI dated.01.01.2024, is hereby modified with necessary correction / incorporation and substitution as detailed below:-

1. So far as the availability of space is concerned, initially if it is found fit for 05 (Five) machines, proposal shall be submitted accordingly. However if subsequently adequate space is provided then the service Provider has to enhance the Dialysis Units, which can be accommodated with the same terms and conditions as laid down.
2. The minimum turnover mentioned at Point No.3.3 may be read as ₹5.00 crores instead of ₹.1.50 Crores.
3. So far as the issue arose relating to Sl.No14 of Para.5, this is to clarify here that the complicated patients shall be shifted to any tie-up SST care Hospitals if needed with the existing transportation Ambulance facilities available in those two ESI Hospitals and for that the Service Provider don't have to pay neither the charges of shifting and further treatment at SST Care Hospitals. The same shall be ensured by the Medical Superintendent of concerned ESI Hospitals and borne by the ESIC.
4. The expertise service of a Nephrologist shall be made available by the Service Provider as and when required and the detailed profile as mentioned in this Directorate earlier Publication shall have to be adhered to.
5. Under Para-7 at Sl.No.6, the sentence written as "The Dialyser should be used for more than five (05) times or 70% of bundle volume whichever is achieved earlier" may be read as "more than ten (10) times or 70% of bundle volume whichever is achieved earlier".
6. The figure of CKD patients undergoing dialysis at present is around 250.
